- The Chairman and Company Secretary informed that the Company has taken all feasible efforts under the current circumstances to enable members to participate through video conference and cast their votes electronically. He also informed the Members that the necessary registers and documents referred to in the Notice of the 27<sup>th</sup> AGM were available for inspection.
- The Chairman delivered his speech and briefed the Members on the Operational and Financial performance of the Company for the financial year ended 31<sup>st</sup> March, 2020 and outlined the Company's expansion plans and strategies. He expressed confidence that the Company's performance would further improve in the current year.
